## Description of costs:

**Product Costs:** All costs and associated charges related to the shares that can be traded

**Service Costs:** All costs and associated charges for the investment services and/or ancillary services provided to you

**One-Off Costs:** Costs you pay when entering or exiting your investments.

**Ongoing Costs:** The costs that are incurred in managing your investments including those incurred by any underlying investments and borrowing. This includes any Annual Management Charge on your client account.

**Transaction Costs:** The cost of buying and selling underlying securities in the fund. This includes implicit transaction costs which are notional costs, inherent in trading and are not physically paid by the fund. The implicit cost is the difference between the mid-market price of an asset immediately before the order is placed in the market and the price that the deal is struck at. This also includes any dealing costs when buying shares within the client account and 0.5% Stamp Duty Reserve Tax for UK Registered Funds.

**Ancillary Costs:** Other costs incurred as part of the service.

**Incidental Costs:** The impact of the performance fee.

**Reduction in Profit:** In the first year, the difference between the performance you could have achieved without fees and performance with fees deducted.

Should you transfer your ISA to another manager a fee of £50+VAT will be charged. Should an ISA be voided as a result of the ISA regulations a charge of £100+VAT will be levied.
